- Corinna discussed the AI Taskforce availability, Canvas Grade updates, and that faculty will get one additional sandbox course in Canvas and the spring course shells on December 16th.

- OTC Equivalency process is ongoing. One ESL faculty was approved and two LEAP faculty are waiting for the approval of the OTC Equivalency Rubric.

- The Student DE Survey received over 400 responses and the OIRP team should have some results to discuss at the December meeting.

- @ONE Cohorts for the OTC Certification courses are closed, but two of the individual courses, Introduction to Course Design and Accessibility are still available.

a. NOCE Local POCR Process Review (Second Read) – Corinna Lopez
Discussion took place regarding the timing of this and it was decided to postpone the review of the document until after the meeting with Samantha Simmons, Cypress DE Coordinator and POCR lead. This will be added to the agenda for the December meeting.

-The discussion about funds for POCR was discussed and Jennifer Oo shared that NOCE's earmarked money was still available.

b. NOCE OTC Recertification (Second Read) - Corinna Lopez

- The recertification document was revised to require 2 hours of professional activities per calendar year. A fifth item was added to include recertification from other approved institutions. The DE log was approved and Corinna Lopez will create a MS Forms document where faculty can log their professional activities. The timeline for recertification for eligibility for teaching online classes was revised. Added DE related conferences as a possible DE activity.

c. NOCE OTC Recertification Workshop (Review/Discussion) – Corinna Lopez -The team discussed a 3-hour workshop for recertification. Discussion took place about the possibility of offering the workshop at different times, including before or after Flex Day and that adjunct faculty be paid. Karla Frizler asked Corinna Lopez to get on the agenda for the Deans and Directors meeting to gather input on the DE instructor training needs.

d. NOCE DE Faculty Handbook (Second Read) – Corinna Lopez

-The updates to the Handbook, including references to the DE Advisory group, DE Coordinator, and high flex were removed. Maria Aceituno will make updates to the Blueprint section and the Handbook will be reviewed in the December meeting. Corinna Lopez will include the recertification process into the DE Handbook once it is finalized.
