- I. The meeting was called to order by the Curriculum Chair Jennifer Oo, at 12:02 p.m.

It was moved by Karen Bautista and seconded by Megan Ly to discuss the revised courses: BUS 100, BUS 101, and BUS 102. In the originator's absence, Kim Tang was designated as his proxy. During the discussion, the committee addressed the use of LTI (Learning Tools Interoperability) plug-in support software for Canvas. It was noted that if the LTI tool is to be included as supplemental material, all associated fees must be clearly listed in both the catalog and class schedule. The committee emphasized the need for further discussion—potentially involving executive leadership—regarding funding options to ensure equitable access for all students. Suggestions included scholarships, book awards, or grants to prevent the course from becoming a financial barrier.

Following the discussion, a vote was taken on the revised BUS courses: **Approval**: Karen Bautista, **Opposed**: Carlos Diaz and Martha Turner and **Abstentions**: Alli Stanojkovic, Megan Ly, and Erin Sherard. As a result, the motion did not pass and will **not** move forward.

It was moved by Erin Sherard and seconded by Megan Ly for the approval of the revised PARN courses. Following discussion, a vote was held regarding the revised PARN courses, including the modification of the SAM code for PARN 101. It was also recommended that course titles be included in the revisions. Additionally, the TOP code and effective term for PARN 275 were proposed to be changed to Spring 2026. The motion passed unanimously.
